Brown, Jennifer Baptiste, Samuel Parisi, Shantale Greenon, Christopher Ciulla, Stephanie Roche, Jeffrey Cerio and Rob Puopolo, and any one of them acting singly, as true and lawful attorneys-in-fact and agents, with the full power of substitution and resubstitution, for the undersigned and in the undersigned's name, place and stead, in any and all capacities (until revoked in writing) to:
